Sub: Temporary approval of affiliation of Jodhpur Institute of Law, Jodhpur National University, Jodhpur for imparting five year BA. LLB law course.

Sir,

Legal Education Committee at its meeting held on 3<sup>rd</sup> May, 2014 considered the inspection report of the above mentioned college. After consideration, Committee made the following recommendations:-

The Legal Education Committee considered the inspection report submitted by the inspection team. After consideration, the Committee is of the view that Jodhpur Institute of Law, Jodhpur National University, Jodhpur be granted extension of approval of affiliation for running five year BA LL.B course with an intake of one section of 60 students for a period of three years i.e. for the academic years 2011-2012, 2012-2013 and 2013-2014 subject to the following conditions. Since extension period for which inspection fees was deposited in contect in 2013-14, college to deposit inspection fee within six weeks for extending from 2014-15.

- 1. Moot court competition be organized on regular basis.
- 2. Legal Aid clinic be organized in rural area.
- 3. Arbitration and Mediation clinic be organized.
- 4. Games facility as available there so the students of Law faculty be directed take part in games/ track.

- 5. The college management is directed to establish the Legal Aid Centre as per Clause-11, Schedule-III of Rule-11 of the Part-IV of the Legal Education Rules 2008.
- 6. College should ensure the payment of salary to teachers as per Rules 22 schedule III, Part IV of BCI Rules.
- 7. The institution is directed to upgrade the library by investing minimum Rs. 50,000/- per year.
- 8. Teacher Student ratio shall be as per Schedule-III, Rule-11, Clause-17, Part-IV of Bar Council of India Rules.
- Institution should submit affidavit in compliance to the above conditions within three months.

The above recommendations were considered by the Bar Council of India at its meeting held on 9th May, 2014 and accepted the same.

College authorities are also required to apply to the Bar Council of India for further extension of approval of affiliation six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31st July, 2014.
