2nd CONVOCATION









The second convocation of Jodhpur National University witnessed legendary personalities being honored for exemplary contribution in their respective fields. The university convocation held in Jodhpur had veteran actor Amitabh Bachchan and environmentalist, hotelier and visionary, Capt. CP Krishnan Nair to receive honorary doctorates from Mr. Kamal Mehta, Chairman, Jodhpur National University.

While Bachchan was conferred a Doctorate in Literature for his exemplary contribution to Indian Cinema, Capt CP Krishnan Nair, founder chairman and chairman emeritus of The Leela Palaces, Hotels and Resorts was conferred the honorary doctorate in Hospitality and Business Management, Legendary superstar Amitabh Bachchan accepted the 'Doctorate in Literature' honor bestowed on him by lodhpur National University for his exemplary contribution to Indian Cinema, Amitabh Bachchan traveled to Jodhpur with wife Jaya Bachchan. All the students wanted to get a look of the 'Shahenshah' of Bollywood. Big B inspired the students by reciting the poem from his hit movie 'Agneepath'.

Mr. JVR Prasada Rao (UN Secretary-General's Special Envoy for AIDS in Asia and the Pacific), Prof. K. Srinath Reddy President, Public Health Foundation of India (PHFI) and Mr. Anil Purohit from US Department of Health and Human Services were also awarded D.Lit. for their outstanding contributions in the areas of public health.

"The Indian economy faces many challenges. We have faced similar problems in the past. Our experience gives us the confidence that we can overcome them.

India will transit from being a low income to a middle income country. We need to overcome the low growth phase as quickly as possible, as growth is the answer to many of our socio-economic problems. In the recent period, we have launched a number dimensions. It has to be inclusive, it must be poverty reducing, and it must be environment-friendly. We need to incorporate all these elements in the growth process. A strong and balanced growth will enable the economy to achieve multiple goals including reducing poverty.

In many ways the coming decade will be crucial for India." said Dr. C. Rangarajan, Chairman, Economic Advisory Council to the Prime Minister (Former member of parliament & Ex-Governer, Reserve Bank of India) while delivering the convocation address at second convocation ceremony of Jodhpur National University.

He added, If India grows at 8 to 9 per cent per annum, it is estimated that per capita GDP will increase from the current level of US\$1,600 to US\$ 8,000-10,000 by 2025. Then of schemes aimed at broadening the base of growth. These include the employment guarantee scheme, universalisation of education, expansion of rural health, and providing food security. All these programmes have made a substantial demand on public expenditure. It has been possible to fund these programmes only because of the strong growth that we have seen in recent years. Growth has facilitated raising more resources by the Government. Development has many

Dr. C. Rangarajan also focused that in the recent period, there have been some discussions on the relative importance of growth and social development. In a fundamental sense, there is no contradiction between the objectives of growth and social development. Economic growth implies improvement in the material well-being of the people which necessarily includes better health, education and sanitation. On the other hand, enhanced social development expenditures cannot be sustained over a long period unless supported by accelerated economic growth. The two are in fact mutually reinforcing forces. Growth will have no meaning unless it brings in its scope the bulk of the population. In effect, the country must learn to walk on the two legs of growth and social development. Growth and equity should not be posed as opposing considerations. They must be weaved together to produce a coherent pattern of development. Therein lies, if I may say so, economic statesmanship.

Jodhpur National University hosts the Course

The course on human rights and drug policy in Asia was hosted at the Jodhpur National University this month, bringing together an internationally renowned faculty that includes scholars from all around the world.

The course in its initial program engaged and trained 35 participants from 13 contries & 10 states of India. The Participants were experts from different fields related to drug policies on the impact of drug laws on human rights protection such as the right to life, health, and freedom from cruel, inhuman or degrading treatment and others.

Mr Kamal Mehta, Chairman, Jodhpur National University said. "The aim of this course is to highlight the need for evidence based empirical analysis of data and evidence to inform Indian, Asian and other countries in drug policy making and its implementation, leading to desirable public health outcomes." He further emphasized, "A mix of teaching modes were used and faculty was encouraged to minimise the use of formal lectures. Emphasis was on discussion and interactive learning. The discussions helped to evaluate and assess the gap between human





rights and practices in the implementation of drug policies within the region and globally."
